Factors that may be considered by the school in determining the appropriateness of a name include: (1) Consistency with the mission, vision, reputation, and values of the school.(2) Whether a name may imply the school's endorsement of a political or ideological position or the use of a particular product or service.(3) Potential conflict of interest. (4) Whether the name reinforces the school's branding standards. (5) Potential conflict with existing named entities or spaces.

Naming is generally granted for the useful life of the entity unless otherwise specified in the gift agreement. The school, at its sole discretion, may revoke a naming.
